Practice

Nirmala College is committed to the task of enhancing the quality and performance of the teachers and students through the adoption and implementation of Best Practices.

Evidence of Success

In order to Enhance the teaching skills and performance of its faculty, the institution regularly organizes Faculty Enrichment Programs. Eminent personalities, scholars and academicians are invited to deliver talk and lectures on different topics that would enlighten the teachers and enable them to upgrade their skills. A Faculty Enrichment Program was organized in college on 22nd June, 2016. Prof. Saraswati Mishra was invited as the Resource Person. Title of the Practice

Career Awareness Programs

Goal

Nirmala College, a Christian Minority Institution is dedicated to the cause of grooming the underprivileged young girls by providing them education and helping them in every possible way to nurture their personalities and enable them to explore their potential, skills, abilities and strengths and assist them to identify future careers. Comprehending the need of creating Career Awareness among the students and sensitize them about various career opportunities, the Institution regularly organizes Career Awareness Programs. The objective of these Career Awareness Programs is to enhance the students' awareness and understanding of career opportunities and equip them with knowledge that would empower them to face the challenges in highly competitive job market and also facilitate their entry into different professions.

The Context

Hailing from economically and socially disadvantaged section of the society, most of the students lack exposure and are unaware of the existing job opportunities. Moreover, the increasing competitiveness in the job market has made it mandatory for the higher educational institutions to device innovative ways to prepare the students for various careers and facilitate their entry into different professions. There is an urgent need for coordination among different agencies for promotion and advancement of an academic atmosphere that enables the students to explore different career opportunities. Keeping in view these concerns, Nirmala College, in collaboration with different institutes and companies, has started the Career Awareness Programs for the students.

The Practice

A Career Awareness Program was organized in the college by the Career Counseling and Placement Cell in collaboration with Jain Aviation International on 11th January, 2017. Captain Nipun Jain, the Resource Person, addressed the students and made them aware of the job opportunities in aviation sector.

Yet another Career Awareness Program was organized by Career Counseling and Placement Cell of the college, in collaboration with Abhyudaya Institute of Management on 24th January, 2017. Mr. Anil Shukla, the Resource Person, made the students aware of the job opportunities in Finance, Accounting and Marketing sector.

One more Career Awareness Program was organized on 16th November 2016 where the Resource Person, Prof. Sarabjeet Kumar of Xavier Institute of Social Service, made the students aware of the employment opportunities available in the field of Business Administration.

Evidence of Success

These Career Awareness Programms have greatly enhanced the students' awareness and knowledge regarding various employment opportunities. The students were guided by skilled professionals from different fields which greatly motivated and inspired them and helped them to realize their potential. This practice has brought a perceptible and positive change in the students and made them aware of the current trends and demands of the job market and helped them in their placements.

Jain Aviation International and the Placement Cell of Nirmala College organised a Pool Campus Placement Drive in the college campus. Jain Aviation International is a placement partner of Indigo Airlines. Almost 200 students participated in this drive. 100 students were selected for the second round of interview. In the third round of interview, Supriya Singh of BCA III was selected and got placed with Indigo Airlines.

In addition Shivani, Jyoti Sri and Suraiya Khan of IT III got placed with Concentrix Daksh. Ranjana Priya and Kajol Pandey of BCA III got placed with Edge Telecom and Internet Global and Sonali Kumari of BCA III got placed with Tech Mahindra.

Problem Encountered and Resources Required

As majority of students hail from underprivileged sections of society, there is a lack of awareness among them regarding the importance of these programs.

However the organization of such program at regular intervals has made them more aware and confident regarding career opportunities. Human resource and e-resources like emails and messenger applications were required to make the career awareness programs successful.
