

BEST PRACTICE – 2

Title of the Practice

Empowering the young women by expanding their horizon.

Goal

To prepare, an academically sound, confident, young woman who is aware of her rights, duties and responsibilities in the present globalized world.

The Context

The challenging issue about this goal is to bring a transformation in the personality of the girl students coming from a rural background into progressive, confident, educated women with scientific bent of mind; who is aware of her rights and duties. Jharkhand still reflects the medieval mind set where people believe in Superstitions, Witchcraft, prevalence of outdated rituals, trafficking, intoxication, poor health and hygiene . The college is committed to serve the economically underprivileged tribal girls.

The Practice

The college makes conscious efforts to tap those channels which can provide insightful information about women's rights.

On the directives given by the Principal, the Women's Cell and NSS wing of the college co-ordinates with those institutions of the society, which deals with the problems of women. They also invite women achievers to motivate the students in the right direction.

In 2011, the NSS wing of the college invited eminent lady doctor of the city, Dr. Shobha Chakraborty and Mrs. Rama Khalkho, the Ex-Mayor of the city and an ex-student of the college on 8th March, International Women's Day celebration, to address the students. The UN theme of that year "Equal Rights and Equal Opportunities" was the theme of address spoken by the esteemed guests. The girls were very impressed and motivated by them.

The college is in the capital city of Jharkhand which also has the State's High court. Since gender disparity is a burning issue for the nation, the Jharkhand State Legal Service Authority, sent its officials to spread legal awareness amongst girl bodies and the scheme of free legal services offered by them. Similarly in March 2013, the NSS wing of the college took thirty students to a Legal Awareness Programme organized by Ranchi University, Ranchi, in the Aryabhatta Auditorium, to attend the lecture delivered by the eminent judge of the Supreme Court, Shri M.Y. Iqbal, Shri Prakash Tatia, Shri D.N. Patel, judges of the state high court.

The Women Cell of the college is also vibrant and dynamic and teaches the idea of equality and self-worth to the girls. State as well as nation's major women's issues are

highlighted by the cell on different occasions; be it organizing the march to protest against the Delhi-rape case or UN themes of International Women's Day "Equal Rights and Equal Opportunities".

In 2013, on Women's Day the cell invited chairperson of Jharkhand women's commission Dr. Hemlata S. Mohan, who spoke on the theme "Time for Action to End Violence Against Women". She spoke lucidly about how children and women were particularly vulnerable to violence. The girls put up their queries and it became a very fruitful interactive session.

The Women's Cell collaborated with Randhir Verma memorial foundation and Ranchi Police to deliberate upon "Better Security Protection Network". Zonal IG Mr. M.S. Bhatia along with all the high officials and Thana-in-charge of the locality of the college came to assure safety for the college girls. On the request of the girls, a security personnel has been deployed outside the college.

The serious issue of domestic violence was discussed in the college in a seminar organized by the women's cell and NSS wing of the college in March 2014. The chief guest, Dr. Hemlata S. Mohan, ex-Chairperson, State Women's commission Jharkhand, gave practical tips and knowledge on Domestic Violence Act. She responded to many queries of the girls. Rose Kerketta, Retd. Prof. of Tribal Regional languages, Ranchi University, Ranchi and Dr. Saraswati Mishra, Dean Faculty of Humanities, Chairperson of Women's grievances cell, Ranchi University Ranchi, spoke on women issues.

The young women of the college are not only made aware of their rights but also about their duties. The NSS wing of the college in association with Student's representatives of Campus Ambassador, Election Commission, Ranchi; organized a voting awareness program for youth before the General Election 2014. The student representatives of Campus Ambassador Election Commission presented a 'NUKKAD NATAK' focusing on the necessity of properly exercising the right to vote and its consequences.

Evidence of Success

Discussions of women related issues have created a positive impact on the minds of the students. Eminent personalities address them, which is motivating and inspiring.

Ever since these programmes of interactions have been launched, there is a remarkable change in the attitude and aptitude of the students. They have become more confident, responsive and eager in the classrooms as well as while participating in any of these programmes.

Another evidence of success is, that the students are winning more prizes in various competitions organized by other colleges or by Ranchi University, Ranchi.

Problems Encountered and Resources Required

Hailing from economically and socially disadvantaged section of the society, most of the girls are shy, hesitant, lack confidence, suffer from inferiority complex and have poor communication skill.

To nurture, evolve and empower them, the institution undertakes various measures like remedial classes, personal counseling with students and parents, if required. Co-curricular activities are organized in which the institute invites professional counselors, legal experts & security personnel etc. Extracurricular activities under professional guidance also hone their raw talent in a better way.
